1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The property comprises a two storey, detached dwellinghouse with substantial outbuildings set in approximately 15 acres of surrounding garden grounds.
Accommodation	The accommodation may be summarised as follows: Ground Floor - Entrance Vestibule, Utility Room, Kitchen/Dining Area, Lounge with Sun Room off, Main Hallway, Sitting Room, Bathroom, Study, Bedroom with En-Suite Shower Room, Gym. First Floor - Landing, 5 Bedrooms (3 with En-Suite facilities), Shower Room
Gross internal floor area (m²)	339 or thereby.

Neighbourhood and location	The subjects are situated in rural surroundings, occupying an elevated position within the Culnakirk area on the western outskirts of Drumnadrochit. Immediate surrounding properties comprise scattered residential dwellings, together with open countryside and moorland. There is a range of local amenities within nearby Drumnadrochit, whilst the city of Inverness is situated approximately 19 miles east.
Age (year built)	Circa 2005.
Weather	Dry.
Chimney stacks	There is a chimney stack of rendered block construction.

Roofing including roof space	The roof is of pitched design, clad with slates and incorporating tiled ridging.
	There was access gained to the accessible roof void area via a ceiling hatch within the first floor Landing. Fibreglass insulation has been laid between the Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.
Rainwater fittings	The gutters and downpipes are of plastic manufacture.

	Visually inspected with the aid of binoculars where appropriate.

Main walls The main outer walls are of modern cavity construction comprising a structural timber frame inner leaf and roughcasted concrete block outer leaf. The basecourse is of smooth render finish. Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Windows, external doors and joinery The windows comprise modern replacement uPVC double glazed units which we understand were installed in 2017. In addition, there is also a double glazed timber framed Velux at first floor level. The front entrance door is of composite type, whilst there is also a timber framed rear external door. There are uPVC, double glazed French doors of the Sun Room. The external roofline fascia boards are predominantly of timber type with the exception of uPVC sections. Internal and external doors were opened and closed where keys were available. Random windows were opened and closed where possible. Doors and windows were not forced open.

Conservatories / porches	The property has had the addition of a single storey, Sun Room extension to the front. This comprises uPVC, double glazed windows whilst the roof is part flat lead clad, and part slate clad.

Garages and permanent outbuildings

There is a substantial agricultural outbuilding to the side of the dwellinghouse. This is of steel frame construction externally clad with profile metal sheeting and with a concrete block base. The roof is also profile metal clad.

Additional outbuildings comprise a game larder/workshop which comprises of concrete block walls under a slate clad roof. This is uPVC lined internally and is also connected to electricity and has plumbing installed.

Visually inspected.

Outside areas and boundaries

From information provided and also from that obtained from an online mapping system, we would note that the total site area extends to approximately 15 acres or thereby. This includes the immediate areas of surrounding garden ground extending to circa 0.7 acres with the remainder being areas of rough ground/moorland.

The immediate garden grounds are laid with grass, paving and gravel.

The boundaries where seen comprise block walling and post and wire fencing.

Initial access to the subjects is via a shared private track, which we understand is outwith the ownership. This subsequently leads to gravel surfaced off-street car parking areas to the side and rear of the dwelling.

Visually inspected.

Ceilings

The ceilings are plasterboard lined.

Visually inspected from floor level.

Internal walls

Internal walls are plasterboard lined.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors including sub floors

The flooring at both ground and first floor levels is predominantly of suspended timber construction with the exception of some solid areas within the former garage and Sun Room extension.

We would, however, emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings.

There was no access gained to any sub-floor areas.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Internal joinery and kitchen fittings

Internal skirtings and architraves are of both varnished and painted timber finish. The doors are of solid timber and timber/glazed type.

The Kitchen units have been upgraded in the past and comprise a modern range of wall mounted cabinets and worktop surfaces with island feature.

There are bi-fold doors leading from the Living Room to the Sun Room.

There is a timber and glazed staircase connecting the ground and first floors.

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

Chimney breasts and fireplaces

There are modern stoves within the Living Room and Sitting Room.

Visually inspected. No testing of the flues or fittings was carried out.

Internal decorations

Internal decorations comprise painted finishes.

Visually inspected.

Cellars

Not applicable.

Electricity

Mains supply. The electrical installation comprises 13 amp power points whilst the cable where visible is of PVC clad type.

The electrical meter and consumer unit is contained within the understair cupboard.

There are a total of 16 solar photovoltaic panels on the outbuilding roof. We understand that these contribute towards the electricity supply of the property with the remainder being fed back into the main grid which provides an additional income. We would recommend that full details be confirmed in this regard.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

Gas

Not applicable.

Water, plumbing, bathroom fittings

Mains supply. The visible plumbing installation is in copper and plastic pipework where seen.

The sanitary fittings within the ground floor Bathroom and En-Suite and first floor En-Suites and Shower Room are all of modern type.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and hot water

Fixed central heating is provided by an oil fired `Grant Vortex 26-35` boiler which is located within the Utility Room and this serves a number of water filled radiators. This also supplies underfloor heating at the lower ground floor Living Room and Sun Room. This also provides for domestic hot water which is contained within a large modern pre-insulated hot water cylinder, which is within a cupboard off the first floor Landing.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage

Drainage is understood to be to a private septic tank which we have been informed is located within the boundaries.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Fire, smoke and burglar alarms

There appears to be a compliant smoke and heat alarm system within the property.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to inspection

At the date of inspection, the property was furnished whilst the floors were covered.

Not all windows and doors were tested during the course of our inspection.

There was no access gained to any sub-floor areas.


We would emphasise that there was a limited inspection undertaken of the overall garden grounds.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a solicitor or licensed conveyancer

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the conversion of the former car garage to form additional residential accommodation, together with the Sun Room extension. We understand that these were added circa 2014.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Drainage, we understand is to a exclusive septic tank which we understand lies within the feu. This was not checked or tested. It should be ensured that appropriate registration documents are available.

Initial access to the property is via a shared private track which we understand is outwith the ownership. Full details should be confirmed in this regard.

We would recommend that the full extent of grounds pertaining to the property be confirmed by reference to the title.

There are a number of solar photovoltaic panels on the outbuilding roof. We understand that these contribute towards the electricity supply of the dwelling with the remainder being fed back into the main grid which provides additional income. Our valuation assumes that this will be transferred to any new purchaser as the date of sale. We would, however, recommend that full details be confirmed in this regard.

Estimated reinstatement cost for insurance purposes

£1,150,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £1,150,000 (ONE MILLION ONE HUNDRED AND FIFTY THOUSAND POUNDS STERLING).

Valuation and market comments

£700,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £700,000 (SEVEN HUNDRED THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

TERMS AND CONDITIONS OF SINGLE SURVEY

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

1.2 The Report

1.6 Intellectual Property

All intellectual property rights whatsoever (including copyright) in and to the Report, excluding the headings and rubrics, are the exclusive property of the Surveyors and shall remain their exclusive property unless they assign the same to any other party in writing.

1.7 Payment

The Surveyors are entitled to refrain from delivering the Report to anyone until the fee and other charges for it notified to the Seller have been paid. Additional fees will be charged for subsequent inspections and Reports, including replacement home reports.

1.8 Cancellation

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the Property, the Surveyor concludes that it is of a type of construction of which the Surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. DESCRIPTION OF THE REPORT

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.





'Assumed' means that the insulation could not be inspected and an assumption has been made in the methodology, based on age and type of construction.

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO_2 emissions, running costs and the savings possible from making improvements.

The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 33 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 11 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 2.1 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.

1 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

2 Wind turbine

A wind turbine provides electricity from wind energy. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Wind turbines are not suitable for all properties. The system's effectiveness depends on local wind speeds and the presence of nearby obstructions, and a site survey should be undertaken by an accredited installer. Planning permission might be required and building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority.
