### LOCATION

Located in the Slateford area of Edinburgh, the property lies approximately 4 miles southwest of The City Centre.

## **DESCRIPTION**

The subjects comprise part of the ground floor of a two-storey office pavilion.

A shared entrance lobby provides access to the subjects. WC facilities are also located within the common areas of the building, with female and disabled facilities located on the ground floor and male facilities on the first floor. A lift provides access to the first floor.

Internally the office suite provides open plan accommodation and benefits from raised access floors, suspended ceilings, kitchenette and newly installed LED lights.

The property further benefits from 3 dedicated car parking spaces with further free of charge parking available in the surrounding area.
